In a separate document, please respond to the following items. Address as many items as you can.

- 1. Describe the factors most responsible for your unsatisfactory academic performance? How did those factors affect your grades each term?
- 2. What has changed in terms of circumstances or behaviors that will assure that the factors listed above will no longer be barriers to your academic success? (Provide documentation whenever possible to support your claims.)
- 3. Describe in detail the plan of action you will follow to ensure that your grades will improve, if you return to the University. Include a list of courses you plan to take and a reason for selecting each one including retakes.
- 4. You were informed that you would be dropped if you received unsatisfactory grades. Describe reasons/make the case to compel us to believe that you would behave differently if given another chance.
- 5. Describe your organizational skills. For example: how did you keep track of assignments for your classes? How did you organize class notes and other materials such as syllabi, handouts, etc.?
- 6. When and where did you study?
- 7. How long did you study each day?
- 8. How much time did you spend in preparation for exams?
- 9. Did you always take your exams?
- 10. When you were receiving unsatisfactory grades in a course, what steps did you take to improve? What would you do differently in your next semester?
- 11. How often did you miss class your last semester of enrollment? Why? How often were you late for class?
- 12. How many times in your last semester did you meet with the professors of your classes for assistance with class work? For other reasons?
- 13. How many times in your last semester did you meet your academic advisor for assistance with scheduling? For other reasons?
- 14. List courses in which you earned B or better grades and explain what motivated you/why it was possible to earn these grades.
- 15. List courses in which you earned D and F grades and explain why you were unable to earn average or better grades in those classes.
- 16. List non-academic areas, e.g., substance abuse, depression, etc., with which you have had problems and indicate how recently.
- 17. List academic areas in which you believe you need assistance and indicate if you have sought assistance. Examples include: reading skills, vocabulary, comprehension, speed, study habits, organization, concentration, note taking, time management/procrastination mathematics/quantitative skills, writing skills, grammar, spelling, developing ideas, choosing a major, motivation, self-confidence, mental health problems/concerns, personal problems, other (list).
- 18. Do you have a disciplinary record? If so, explain when, the reason for the sanction, and the disciplinary sanctions imposed. (You might be asked to provide verification).
